Incremental Renewal Process

- Reminder:
 - Begins again on June 1, 2018.
- No longer able to accept surveys via email.
- You can download sample copies of the surveys.

Reminder - Credentialing Changes

- Credential Renewals
 - 10 hours of mentor coaching required for ACC renewal is now counted as part of the 40 hours of CCEs needed.
 - For those whose credentials expire December 31, 2018, no more than 10 hours of mentor coaching and coach supervision can be counted towards credential renewal.
- Portfolio Applications
 - July 31, 2018 – Those submitting CCE training or non-approved training will need to submit additional proof that their training followed a scope and sequence that encouraged the growth of the coach.
- ACC Credential
 - July 31, 2018 – ACC ACSTH application track will again require the need for an audio recording.
 - July 31, 2018 – ACC coaches will not be eligible to supply mentor coaching unless they have renewed their ACC credential at least once.
- MCC Credential
 - July 31, 2018 – The 2,500 hours of client coaching experience will need to be completed after the start of coach-specific training.
 - February 28, **2019** – Coaches will need to hold the PCC credential before they can apply for the MCC.

Offering Partial Completion

- Times when you may offer partial completion of a program:
 - A student decides to leave a program.
 - Your organization only offered a fast track program (1 module of your larger program).
 - You're an ACTP and a student didn't pass the final exam process.
 - Student started the program and completed the program, but missed several days in the middle of the program and is not able to make up their time.
- What to do:
 - Refer to the certificate guidelines document for assistance as needed.
 - All programs that are accredited are able to offer partial completion
 - I.E. ACTPs are able to offer ACSTH hours. ACSTHs are able to offer CCEs. CCEs are able to offer shorter versions of their CCE programs.
 - If you are an ACTP and ACSTH provider who is awarding partial completion and are not sure if the training is ACSTH or CCE training, the general rule is that if the student has completed 30 hours or more, the training is considered ACSTH training. If they have completed 29 hours or less, the training is considered CCE training.
 - If you are an ACTP and have students who do not pass their exam, you are able to award ACSTH certificates to these individuals.
