The exam may be taken in person at one of Pearson VUE's testing centers, or remotely through Pearson OnVice, a live, remote-proctored testing service that allows candidates to test from their home or office while being monitored by an online proctor. Candidates will receive an invitation to schedule an exam appointment and complete the ICF Team Coaching Certification Exam once the application review is complete. Candidates who require arrangements to take the exam must submit the ICF Exam Accommodations Request Form, along with the required supporting documentation verifying the candidate's disability or qualifying medical condition.
